### Minutes of 5/21/19 GLOW WDB Meeting

Mary Williams made the motion to approve the 5/21/19 meeting minutes; Dave Rumsey seconded the motion, all GLOW WDB members present at the meeting were in favor, and the motion was carried. The 5/21/19 GLOW WDB Meeting minutes are approved.

# P.Y.2018 GLOW WDB Budget Modifications – Jay Lazarony, GLOW WDB Director

An amended policy was sent to members prior to the meeting. <u>VOTE></u> All members present at the meeting were in favor of approving the GLOW WDB Youth Work Experience Policy as presented and it is approved.

Service Provider	Funding	Details
Genesee JDB	Youth	Moving \$6,596 from Youth participant expenses. Of that amount \$6,326 is being moved to wage and fringe and \$270 to Operational Expenses. This covers the increase amounts of time on outreach efforts and staff training.
WCCA	Adult	Moving \$1,000 in Adult wage and Fringe to Adult Participant expenses to cover cost of training program. In addition, WCCA is moving within the operational budget line \$500 from RUM to other operational. The operational line remains unchanged. WCCA is also moving within the Participant Budget lines \$1000 from Wage and Fringe to the supportive service line. WCCA is also moving unspent OJT of \$6,749 and Customized Training of \$5,800 to the ITA line.

WCCA	Youth	WCCA is moving \$2,600 from the operational line to the participant line. Of that \$1,900 is being moved to Work Experience and \$700 is being moved to participant support. In addition WCCA is moving \$5,470 within the participant line from the training to Work Experience.
GLOW WDB	DLW Formula	GLOW WDB is moving \$2,000 in DLW Formula funds to Livingston
		County to support 1 ITA Training. GLOW WDB is also moving \$100 in supportive Services to Livingston County to Support 1 Customer.
GLOW WDB	DLW Formula	GLOW WDB is moving \$1,692 of DLW Formula to Orleans County
		JDA to support 1 ITA Training. GLOW WDB is also moving \$500 in supportive services to Orleans County JDA to support one
GLOW WDB	Adult	GLOW WDB is moving \$3834 in Adult funds to Genesee County to support 2 ITA trainings and \$850 in Adult funds for supportive services for 2 clients.
Orleans County	Administrative	OCJDA is moving \$270 of Admin within the operational line from other operational to Rent/Utilities/Maintenance.
GLOW WDB	Adult	GLOW WDB will transfer \$6938.60 in Adult funds to Orleans County Wage and Fringe.
GLOW WDB	Adult	GLOW WDB will Transfer \$8854.01 in Adult Funds to Livingston County Wage and Fringe. In addition Livingston County will transfer \$5,415.86 from the operational line to the Wage and Fringe line.
