## <u>Guest Speaker – Senator Robert Ortt, Special Assistant for NYS Senate</u>

State Sen. Rob Ortt, co-chair of the Senate Task Force on Workforce Development Committee, talked about the continued need for education to line youth up with the jobs that are out there. He said Albany needs to work more with workforce staff in the four counties because they know what employees and employers need.

He said GLOW has great leadership, good structure, and have buy-in from all counties. He noted he has visited more manufacturing places in Western New York. The customers are all over the place. These jobs are highly technical and require more skills.

# Closing Remarks – Jay Lazarony, GLOW WDB Executive Director and Norb Fuest, GLOW WIB Chairman

Jay noted that with funding cuts, the WDB now provides training that is suitable for job seekers and more efficient cost wise. The GLOW trained 153 customers for \$191,250 at an average of \$1,250 per person. He congratulated all of the recognized business, participants, and youth, and thanked the staff of all the centers for their dedication in serving their customers. He thanked Norb Fuest for being an exceptional leader for this board. He thanked the Vice Chair and Finance Committee Chairman, Dennis Burke for his long time involvement, and all of the board members for their dedication and effort in providing a skilled workforce in GLOW. He thanked Kristine Langless for the fiscal work she provides for the WDB, and Michele Nichols, GLOW WDB Assistant, for all of her assistance. The WDB is planning a new event, GLOW Works With Their Hands, September of 2019, which will host GLOW school students with the opportunity to attend and learn and hands-on with skilled trades in manufacturing and agriculture. Details will be forthcoming.

Norb noted that 27,000 people came through the Career Centers in GLOW. The WDB needs to be more efficient and is still pursing becoming a non-profit 501c3 to apply for more grants, which will present opportunities to help more people in the future.
