<u>Orleans County Job Development Agency summary of Budget Request Modifications, Jay Lazarony,</u> GLOW WDB Executive Director

Jay presented the following budget modifications for Orleans County Job Development Agency that will be a stand-alone recommendation as the final requests were not able to be presented to the Finance Committee:

- Orleans County Job Development Agency transferring \$15,000 from DLW Wage and Fringe to DLW Participant Expenses for ITA's
- Orleans County Job Development Agency transfers \$3,000 DLW Supportive services to DLW ITA's (no change in cost category)
- Orleans county Job Development Agency transfers \$650 from other operational expenses to Rent, Utilities, and Maintenance (no change in cost category)
- Orleans County Job Development Agency transferring \$3,000 from Adult Participant Expenses to Adult wage and Fringe.
- Orleans County Job Development Agency transferring 3,000 from Adult Participant Expenses to Adult Operational Expenses (2,000 in other Operational and \$1,000 to Rent, Utilities, and Maintenance.

VOTE> Dennis Burke made the motion to approve the Orleans County JDA budget modifications as presented; Darren Burdick seconded the motion; all members present at the meeting were in favor, and they are approved.

GLOW WDB Executive Director's Annual Report

Jay presented what the GLOW WDB has accomplished this past year in P.Y.2017, which includes:

- The execution of the GLOW Memorandum of Understanding with all Partners for Part I and have completed Part II, the MOU Infrastructure, and submitted to NYS DOL for review and signatures.
- ➤ GLOW secured Genesee Finger Lakes Regional Council as the One Stop Operator for continuous improvement, which includes a pilot for a referral process between partners to identify co-enrollments and a seamless process of services. During the next year, there will be a roundtable identifying all partners programs for more efficient services for customers.
- The first Request For Proposal was done for Wyoming County WIOA Title IB Adult and DLW services and was contracted with Wyoming County Community Action. WCCA did an excellent job and had a very successful year.
- ➤ Earlier in the year there was discussion on the possibility on recapture of funds due to underspending. The spending requirement is 80%. Jay is happy to report that he sent out the GLOW Spending Tracker as of May, 2018, which shows spending percentages of:
 - o Adult 81.92%
 - o DLW 73.96%
 - Also an Additional \$47,000 of DLW to Adult, which was part of recapture funds from P.Y.2016, was 100% spent on participant training.
- > Jay thanked all of the GLOW Service Providers, Darren, DOL Manager, and all partner staff for providing great services.
- The WDB will apply for a Consolidated Funding Application (CFA) grant to provide precision machining training through GV and identifying employers to hire upon completion of training.
- ➤ Literacy West secured \$500,000 for the Adult Basic Education, Literacy Zone from the Title II Adult Education grant.
- The TANF Summer Youth Work Experience programs will be starting soon, which are run by the GLOW Career Centers if you are interested in having a youth for work experience, please contact them
- > Jay thanked all the members and partners and Michele and Kristine for assisting him during this past year. He thanked Norb for always being there and he couldn't ask for a better chairman for this board!

Norb thanked Jay for getting things moving in the right direction! He thanked Tim for chairing the new Emerging Worker Committee and Dennis for leading the Finance Committee on some challenging issues. Norb noted that he sees the future of greatest money is applying for grants after becoming a 501c3. We are in process of working with the CEOs and WDB Executive Committee to establish this corporation.

Norb recognized Dave Rumsey for doing a great job as the Youth Council Chair for the past two years. He also thanked Joe Hamm for his involvement on the GLOW WDB for the past 8 years, which Darren Burdick will now represent. Norb recognized RZ Lampley, who was one of union representatives on the GLOW WDB, who recently passed away.

<u>VOTE></u> Dennis Burke made the motion to adjourn the meeting at 5:45 p.m. and Bob Molisani seconded the motion, all members were in favor, and the motion was carried.
